Treasurer's Report

This year has certainly been a learning experience. I appreciate everyone's support.

Revenue

Homeowners Dues - (Over budget \$15,075.00) The homeowners association received much more revenue than it normally would. The builders who in the past paid their dues in arrears chose to pay their dues in advance as do the residential members. Additionally, we were able to reduce the number of delinquent members down to two. This resulted in a surplus of \$15,075 over what was budgeted for the year. Past reports didn't indicate this amount as the Quickbooks program was reporting on an accrual basis and I was tracking the budget on a cash basis. I have changed the settings in Quick Books and the reports should be accurate going forward.

Expenses

Computer & Internet - (Over budget \$523.60) There was nothing paid from this account in 2019, so I didn't anticipate any expenses for 2020. The expenses paid this year were for Quickbooks, the website, and a month's subscription to Survey Monkey for the fence poll we took.

Fees - (Under budget \$173.00) The Quickbook fee was initially scheduled to be paid from this account before I switched it to Computer & Internet. Fees paid this year were for reporting requirements to the Secretary of State and for the Post Office Box rental.

Insurance - (Under budget \$716.00) The liability insurance coverage was paid prior to the turnover of the board from the builders to the residents. In June, there was an additional expense to cover the addition of the south water retention basin that had not been reported to the insurance company. I had anticipated an additional expense in the second guarter based on 2019 expenses that did not occur in 2020.

Landscaping & Groundskeeping - (Over budget \$2,784.97) Although we did not initially budget for improvement in 2020, the cost savings the association gained from switching to A Plus Yard Services for commons yard maintenance allowed for improvements to the front entrances and Summerbrook Corner. Overages in General Maintenance and Summerbrook Corner budgeted expenses were partially made up by reductions in Pond Improvement, Entrance Improvement, and the Adopt a Tree program.

Office Supplies - (Over budget \$163.83) I did not anticipate when the budget was developed, additional copies and postage to mail out proposed by-law changes. I do not anticipate this additional expense to occur every year.

Postage & Delivery - (Under budget \$65.00) I neglected to split out the postage for the proposed by-law changes, so that expense should have been in this category and would have resulted in this also being over budget.

Professional Fees - (Under budget \$1,360.00) We had lower tax preparation expense than I anticipated. I subdivided this expense category midway through the year to track anticipated legal expense to address bylaw issues. The subdivision has not yet been billed for work that Harold Adams has done to date.

Rent Expense - (Under budget \$100.00) Anticipated rental of a facility for the annual meeting didn't occur due to the pandemic.

Utilities - (Over budget \$56.72) - I did not anticipate additional expense for water service at Summerbrook Corner.

Overall, we spent \$1,115.12 more than budgeted, but due to the additional revenue from dues collected, the association ended up with a \$21,257.88 surplus for the year.
